(1) DEMAND NO. 14 -DEVELOPMENT OF TRIBAL AND SCHEDULED CASTE :

Shri O. Ibobi Singh, Chief Minister to move :

“that a sum not exceeding Rs. 88,61,33,000 be granted to defray the charges which will come in course of payment during the financial year ending 31st March, 2008 in respect of Demand No. 14 - Development of Tribal and Schedule Caste.”

(2) DEMAND NO. 15 - FOOD AND CIVIL SUPPLIES :
