Up to 2004-05, the Macro Management Mode of Agriculture was implemented by (i) Cooperation Department, (ii) State land Use Board (Revenue Department) (iii) Horticulture & Soil Conservation Department and (iv) Agriculture Department. From 2005-2006 onwards the said scheme was implemented by the Horticulture & Soil Conservation and the Agriculture Department.
(b) the work taken up under the Central Sponsored Scheme in the 5 Hill District during the last 3/4 years (component wise) with list of beneficiaries?	(b) The works under the scheme during 2006-07 in respect of Agriculture Department in the 5 (five) hill districts are still continuing. Due to increase in height, there will be increase in the self weight of the gate and also increase in water pressure. These additional load/forces will be transmitted on the piers and the structure will not be safe.
